VI. **OLD BUSINESS**

● **Public Works Director's report (Greg):**

- a) CDOT's involvement with the Arizona Trail project continues. Olson will have the final design within a couple weeks. The Town consultant is working on a couple easement & ROW issues. CDOT will issue final approval and construction is expected to begin by late summer 2017
- b) Peaks View Trail wash-out at the bottom of the N/S hill appears to be the result of a unmaintained ditch. BOT could direct Town to ascertain land-owner responsibility.
- c) Some trails clean-up will be done by 25 Clearview Church members on their May 15th Community Day.
- d) Gregg Dr. Trail paving is postponed to 2018, as 2017 funds have been re-directed to the Arizona Trail project.

● **Brochures (Ed):**

- a) Mock-ups of 3 potential map designs were discussed. Following discussion, it was decided to use the larger, close-up of Town trails, with the southern (Django, Fistful, etc...) and Wildlife Trails depicted on the flip side.
- b) In order to include the Whipple Trails, as a replacement for FoF's separate Whipple Map, it was decided to not include the photos & historical information as that information is supplied at historical kiosks along the trail.
- c) Discussion regarding map items for inclusion resulted in removing DPCA, Ice Rink, "Pathway" on key, red line depicting trail on 304 (label it Midland "Route") since it is a road with motorized traffic.
- d) All old logo symbols will be replaced with the new Town logo symbols.
- e) Printing is anticipated to be done in April.

● **Memorial Benches map/dog stations (Kathy):** Kathy inventoried all benches (both memorial & non) and dog stations.

- a) Kathy recommended that no more benches be placed on River Trails. TAB agreed
- b) Kathy noted that there is no consistency regarding dog station signs and recommended that we choose a sign design and replace all with consistent signage. TAB agreed. Greg is looking into cost and budget.
- c) Kathy reported that Pat will be the liason with Corrections regarding dog station supply.
- d) It was discussed and agreed that TAB recommend locations for new Memorial benches and approve future applications.

● **Adopt-a-Trail (Nancy):** No report

● **Town Trustee Meetings & Talking Points (January- Kathy & Brad):**

- a) Kathy reported that she spoke at Public Comment regarding the lack of communication between TAB &

BOT, which leads to some confusion as to TAB's role/responsibilities.

b) Brad listened in on the meeting he attended.

- **BLM Trails Update (Emily):** The second sub-committee meeting was held Monday, Jan 30th, 2017

a) Emily made a concerted effort to get motorized-user representation

b) There were 3 motorized trail & 5 non-motorized trail recommendations

c) It was decided to present 2 separate proposals (motorized & non) to increase the chance that something would make it through the process.

d) Emily is drafting the proposals for the next sub-committee meeting, which will be held in the next several weeks.

e) BLM is still writing up the reports regarding the Midland Hills Bridge trails. Needs to get done in order to schedule SCC crews.

- **Branding (Emily):** Emily will look into having "Trails" added underneath the Town logo to use on the brochures & TAB letterhead.
